This warranty excludes any installation, removal and freight costs involved in the product replacement.   factory applied finishes should be maintained on a regular schedule to realize maximum life of
  these products.

- Damage caused by chemicals or a harsh environment unless otherwise stated above.
- Product failure due to misuse or abuse; damage caused by failure to properly finish and provide maintenance, by alteration or modification to the product or as a result of any cause beyond the control of Maxam.
- Improper installation not in conformance with Maxam's installation instructions or current industry standards; problems related to flaws in building design or construction.
